

# Faculty of Education and Social Work Postgraduate International Student Scholarship

## Description

---

The Scholarship was established in 2016 and is financed by the Faculty of Education and Social Work.

The main purpose of the Scholarship is to support international students to enrol into a specified postgraduate programme at the Faculty of Education and Social Work, and successfully establish themselves in Auckland.

## Selection process

---

- Selection Committee assesses potential candidates
- Nomination is made to the Scholarships Office
- The Scholarships are awarded by the University of Auckland Council on the recommendation of the Selection Committee

## Regulations

---

1. The Scholarship will be known as the Faculty of Education and Social Work Postgraduate International Student Scholarship.
2. The Scholarship will be awarded biannually, and will be of the value of up to \$7,000 for 240 points of the programme, or on a pro-rata basis for programmes of less than 240 points.
3. The Scholarship will be awarded to international students applying for admission to a specified postgraduate programme at the University of Auckland Faculty of Education and Social Work (See Note I).
4. To take up and be paid the Scholarship, the candidate must be enrolled and have paid the fees, or arranged to pay the fees, for full-time enrolment in a specified postgraduate programme in the Faculty of Education and Social Work (see Note I).
5. The Scholarship is tenable by international students.
6. The basis of selection will be academic merit as measured by meeting the eligibility requirements for admission to the postgraduate programme (see Note III).

7. The Scholarship will be awarded by the University of Auckland Council on the recommendation of a selection committee comprising the Deputy Dean - Faculty of Education and Social Work (or nominee) and the Associate Dean International of the Faculty of Education and Social Work (or nominee).
8. The Scholarship will be paid as a compulsory fees credit in the first semester of enrolment (see Note II).
9. The Scholarship may be held concurrently with any other award or grant as long as a) the terms of that award or grant permit and b) the University of Auckland Council is informed and approves.
10. The University of Auckland Council has the power to terminate or suspend a Scholarship if it receives an unsatisfactory report on the progress of a Scholar from the Deputy Dean of the Faculty of Education and Social Work.
11. The University of Auckland Council is not obliged to make an award if in any year there is no candidate of sufficient merit.
12. The University of Auckland Council has the power to amend or vary these Regulations, in consultation with the Faculty of Education and Social Work, provided that there is no departure from the main purpose of the Scholarship.
13. Notes [I]-[III] below are deemed to be regulations.

- I. *Specified programmes are: Bachelor of Education (Teaching)(Honours), Bachelor of Social Work (Honours), Master of Counselling, Master of Education, Master of Educational Leadership, Master of Education Practice, Master of Social and Community Leadership, Master of Social Work, Master of Social Work (Professional), Master of Teaching (Primary), Master of Teaching (Secondary), Master of Professional Studies in Education, Postgraduate Diploma in Counselling Theory, Postgraduate Diploma in Education, Postgraduate Certificate in Education, Postgraduate Diploma in Educational Leadership, Postgraduate Diploma in Professional Supervision and Postgraduate Diploma in Social Work.*
- II. *Compulsory fees are those only related to the relevant programme of study, plus Student Services Fee.*
- III. *The academic merit for this scholarship is equivalent to the admission requirement of a programme listed above. Please refer to the Admission regulations of the programme for details.*
